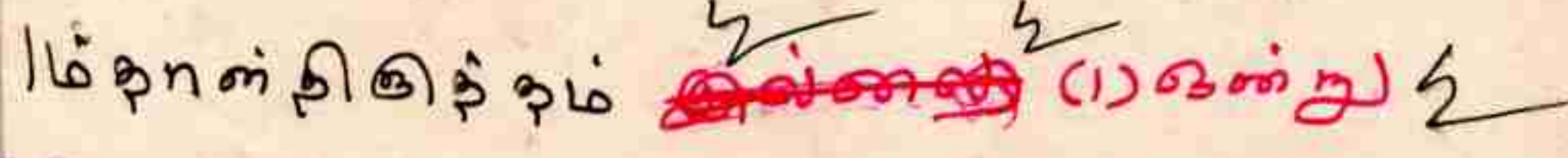

Manikantan, son of Shri M.Sree Krishna Pillai, aged 45H1 du, Landlord, residing at "Saraswathi Bhavanam", Kottumangalam, Mondaikadu P.O., Kanyakumari D istrict (hereinafter called "the Founder") in favour of the persons mentioned hereunder called the Trustees who are also members of the Managing Committee of SREE KRISHNA EDUCATION TRUST .1. S.K. Manikantan, son of Sri. M. Sree Krishna Pillai, aged 45, residing at "Saraswathi Bhavanam" Kootumangalam, Mondaikadu P.O. Kanyakumari District (PRESIDENT) 2. Mrs. K. Vimala Bai, wife of S.K. Manikantan, aged 39, residing at "Saraswathi Bhavanam", Kootumangalan, Mondaikadu P.O., Kanyakumari District. 2. M.P. Krishna Pillai, son of Mathew Pillai, aged 53, residing at Perum selvavilai, Alqor Post, Kanyakumari District.---(1) S.K. Manikantan (2) K. Vimala Bai (3) M.P. Krishna Pillai. 2--WHEREAS the Founder above mentioned had decided to establish a public charitable trust known as Sree Krishna Education Trust for the purpose of running an educational institution by the name of SREE VIVEKANANDA MATRICULATION SCHOOL for the purpose of imparting school education generally and in particular, to the local residents who are now backward in education and left without proper and adequate facilities and to inculcate high sense of discipline among teachers and students. WHEREAS the founder is collecting funds from the members of his family and his friends of Charitable mind and interested in establishing institution like this, from India and also from ^{(1) (abroad)} ~~(abroad)~~ WHEREAS the founder is prepared to contribute further assets for the establishment of the Institution or Institutions of like nature in furtherance to achieve the above object.---(1) S.K. Manikantan (2) K. Vimala Bai (3) M.P. Krishna Pillai. 3--WHEREAS the Founder has applied for permission to start and run a School. WHEREAS it is considered expedient to make a formal declaration of his contributions and collections to the SREE KRISHNA EDUCATION TRUST. AND WHEREAS it is expedient to entrust the administration and management of the Trust, and all institutions and assets of the Trust to a body of persons, appointed as Trustees as per this deed. NOW THIS DEED WITNESSETH that the Founder has earmarked an amount of Rs.1000/. (Rupees One thousand only) towards the corpus of the trust---(1) S.K. Manikantan (2) K. Vimala Bai (3) M.P. Krishna Pillai. 4--DEFINITIONS: FOUNDER means S.K. Manikantan Education Institution means school or such other institutions, colleges, Pharmaceuticals, Polytechnics, Training Schools, Colleges, for business management attached to or forming part of the same or under the management of the Trust. TRUSTEES means the persons mentioned above in whose favour this deed is declared. BOARD means the Board of Trustees constituted with Trustees mentioned above and the members co-opted or nominated by the Founder but so as not to exceed the maximum of fifteen. The Founder shall be the President for his life-time. After his life time, the Tr

Trustees shall elect a President for the Board from among themselves. The minimum number of members of the Board shall be not less than Three. The Administration of the affairs of the Trust shall be vested in the Board of Trustees, who are the members of the Board, but the day to day affairs of the management and the duty to implement the decisions of the Board of Trustees shall be vested in the President. OBJECTS OF THE TRUST (a) To open run and continue school named SHREE VIVEKANANDA MATRICULATION SCHOOL FOR THE EDUCATION OF the students in Arts and vocational pursuits and to develop character of the students as well as to educate them in physical culture (b) To establish and maintain a boarding house for the students who receive education in the School. --- S. K. Manikantan (2) K. Vinayalaxmi (3) M. P. Krishna Pillai (4) 5--- PROPERTIES VESTED IN THE TRUST BOARD The Trustees shall hold all the properties ^{(b) and funds (3)} transferred to them by this Deed ^{(c) (d)} and any other properties and funds which may discover to be the trust properties and properties which may hereafter ^{(c) (d)} be endowed to or acquired by them for the use and purposes of the Trust or any other institutions started or taken over as provided supra. The Trustees shall from and out of the income realised from the Funds and resources of the Trust, and from other sources of income such as endowments, subscriptions, contributions and grants-in-aid which the school may get, expend such sums of money as the Board may deem fit and proper, towards the maintenance of the School, and other institutions; in regular and suitable conditions, pay all the rates, taxes and other dues which may become due. AND meet all expenses which the Board may in their discretion think necessary for the proper and efficient management of the Institutions, in particular, pay salaries, wages and allowances of staff and servants, purchase books, equipment and furniture, award prizes and scholarships to the students and incur any other items of expenditure relating to the Institution under the management of the Board not herein-before specifically mentioned, it being understood that the above enumeration is not exhaustive. Powers and Duties of the Board and Trustees: The Board shall be in complete management of the affairs of the school and other Institutions under this Trust. Without prejudice to the above-said general powers, the Board of Trustees shall have powers, --- S. K. Manikantan (2) K. Vinayalaxmi (3) M. P. Krishna Pillai (4) 5--- 1. to purchase or take on lease lands, buildings, equipments, materials and things to erect and maintain building and other constructions, and to sell, mortgage or dispose of or otherwise deal with all or any of the same as they may think fit and proper in the best interest of the Trust. 2. to levy such fees from the students and to deal with the proceeds as they may think proper. 3. to grant loans or borrow moneys as they may think fit and proper consistent with the management of the Trust. 4. to control and manage the assets of the Trust and to execute, become a party to, sign, acknowledge, prepare and register all deeds, agreements, contracts, receipts

and other documents and writings and to give effectual discharge on behalf of and against the Trust. 5. to sell, exchange and deal with any stocks, funds, shares, bonds debenture stocks and other securities. 6. to borrow from time to time such sum or sums of money on such terms with or without securities, movable or immovable as they may think fit and to secure payment thereof by mortgage or bond, promissory notes, bills, hundies and other negotiable securities or by issue of debentures. 7. to institute, conduct, defend compound, withdraw, compromise, adjust, refer to arbitration or abandon any legal or other proceedings, claims or disputes by or against the Trust, and to authorise by resolution one or more of the Trustees for the purpose. 8. to open and close accounts in the name of the Trust, in any scheduled bank as defined in the Reserve Bank of India, Act, 1934 and to authorise by resolution any one or more of the trustees to operate such Bank Accounts on behalf of the Trust. 9. to insure and keep insured if deemed expedient all or any of the buildings and other assets of the Trust. --- S. K. Manikantan & K. V. Venkatasubramanian & M. P. Krishna Pillai 7---10. to invest the surplus funds of the Trust in securities in any such manner as they may think fit and proper in the interest of the Trust. 11. to appoint from time to time members of the teaching staff and other employees of the school and other Institutions on such terms and conditions as to duration of office and remuneration as they may think proper and at any time to suspend, discharge, dismiss or to take any disciplinary action against them. 12. to delegate all or any of the powers, authorise and directions, vested in the Trustees and generally to carry out such transaction as they consider expedient in the interest of the Trust and to make all such arrangement and do such acts and things on behalf of the trust as they may be usually necessary desirable or expedient in the management of the Trust or in carrying out its objects. 13. the Trustee should not be given any remuneration. 14. they may be reimbursed actual out-of pocket expenses only. 15. they shall not be entitled to any share in the income or property of the trust. --- S. K. Manikantan & K. V. Venkatasubramanian & M. P. Krishna Pillai 8---16. In the event of winding up the properties of the Trust shall be transferred to any other Trust or institution having similar objects; and no part of it shall be transferred to any trustee or a Board Members. The Trustees shall have powers to frame rules for proper conduct of the affairs of this Trust but so as not be inconsistent with the provisions hereof. The value of money conveyed under this deed is Rs. 1,000/-. (Rupees one thousand only).
